Re: Scrutinizer's Report on voting through remote e-voting and voting at the AGM in terms of provisions of the Companies Act, 2013 read with the Rules issued thereunder.

- A. I, Sandeep Dar, Proprietor of M/s. Sandeep Dar & Co., Practicing Company Secretaries, appointed as Scrutinizer in the meeting of Board of Directors of the Company held on August 12, 2024 to conduct the following:
 - Remote e-voting process received from the shareholders of the Company pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014; and
 - ii. Voting at the AGM under the provisions of Section 109 of the Companies Act, 2013 read with Rule 21 of the Companies (Management and Administration) Rules, 2014 at the AGM held on Monday, September 30, 2024

read with Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

- B. The Company had availed the remote e-voting facility provided by Central Depository Services Limited (CDSL) for conducting the remote e-voting by the shareholders of the Company. The remote e-voting commenced on Friday, September 27, 2024 at 9:00 A.M. and ended on Sunday, September 29, 2024 at 5:00 P.M. During this period shareholders of the Company holding shares, either in physical form or in dematerialized form, as on the cut-off date Monday, September 23, 2024, were entitled to cast their vote electronically. The CDSL remote e-voting platform was blocked thereafter by CDSL for voting.
- C. The facility for voting through polling paper was made available at AGM for the members attending the meeting and who had not cast their vote through Remote E-voting. On completion of the voting, Company provided to us the list of the shareholders who were present at the meeting either in person or through proxies and who had cast their votes, their holding details and the details of the votes cast on the resolution.

- D. After counting of the votes conducted at the venue of the AGM, through ballot paper, the vote cast through remote e-voting facility was duly unblocked by me as a scrutinizer in the presence of two witnesses, who are not in the employment of the Company.
- E. I did not find any ballot paper as invalid.
- F. Thereafter, the details of equity shareholders, who voted "For" or "Against" each of the resolution that were put to vote, were generated from the e-voting website i.e., https://www.evotingindia.com.
- G. After closure of the voting at the AGM, the report on e-voting was generated and diligently scrutinized.
- H. On the basis of the votes exercised by the shareholders of the Company by way of voting at the AGM of the Company held on Monday, September 30, 2024, I have issued Scrutinizer's Report dated October 01, 2024.
